TRADEMARK PURCHASE AND ASSIGNMENT AGREEMENT

WHEREAS, Luck Stone Corporation ("Seller") is a corporation organized and existing under the laws of the Commonwealth of Virginia, and has an address of P.O. Box 29682, Richmond, Virginia 23242.

WHEREAS, Allemari Stone Limited ("Buyer"), is a West Virginia limited liability company located at 21025 George Washington Hwy, Elk Garden, West Virginia 26717.

WHEREAS,

(1) Seller represents and warrants it uses in commerce the trademark **MASTERCUT** (first used September 10, 2003), in connection with natural veneer stone for vertical walls and landscaping use.

(2) Seller represents and warrants it is the owner, free and clear of any encumbrances, security interests, third-party assignments, third-party agreements or restrictions, of all right, title, interest, and goodwill, in and to U.S. Trademark Registration No. 2947416 and in and to the mark **MASTERCUT** that is the subject of U.S. Trademark Registration No. 2947416 registered for use in connection with "natural veneer stone for vertical walls and landscaping use."

WHEREAS, Buyer is desirous of acquiring from Seller all of Seller's entire right, title, interest, and goodwill in and to and associated with U.S. Trademark Registration No. 2947416 and the trademark **MASTERCUT**.

NOW, THEREFORE, upon payment of [REDACTED] and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Seller hereby sells, irrevocably assigns, transfers and sets over unto the Buyer, free and clear, of any encumbrances, security interests, third-party assignments, third-party agreements or restrictions, Seller's entire and all right, title, interest, and goodwill in and to and associated with U.S. Trademark Registration No. 2947416, and in and to and associated with the mark **MASTERCUT** that is the subject of U.S. Trademark Registration No. 2947416, together with all common law rights, and state, federal, and foreign and worldwide rights therein and related thereto, together with all rights and privileges granted and secured thereby, including the right to sue for all causes of action related thereto, and the right to sue in Buyer's own name and to recover for any damages and profits for past infringement, unfair competition, or passing off related thereto, said rights to be held and enjoyed by said Buyer, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Seller if this assignment had not been made.

Seller hereby represents and warrants it will not execute any writing or do any act whatsoever conflicting with these representations, covenants and agreements, and that it will, at any time upon request without further or additional consideration but at the expense of said Buyer or his successors, assigns or other legal representatives, execute such additional assignments and other writings and do such additional reasonable acts as said Buyer or his successors, assigns or other legal representatives, may deem necessary or desirable to perfect, secure, record, and register said Buyer's or his successors, assigns or other legal representatives, enjoyment of this grant and conveyance, it being understood that the foregoing covenants and this assignment shall bind successors, assigns and legal representatives of Seller and inure to the benefit of the successors, assigns and legal representatives of Buyer.

The Effective Date of this Trademark Purchase and Assignment Agreement is June 28th, 2016.
