The illegality or unenforceability of any provision of this Patent and Trademark Termination Agreement or any instrument or agreement required hereunder shall not in any way affect or impair the legality or enforceability of the remaining provisions of this Patent and Trademark Termination Agreement or any instrument or agreement required hereunder.

This Patent and Trademark Termination Agreement shall be a contract made under and governed by the internal laws of the State of New York applicable to contracts made and to be performed entirely within such state, without regard to conflict of laws principles.
