TRADEMARK ASSIGNMENT

WHEREAS, Assignee acquired all right, title and interest in and to the Trademark at the July 14, 2015 assignment; and

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor and Mirejovsky hereby sell, assign, transfer and convey to Assignee *nunc pro tunc* the entire right, title, interest in and to the Trademark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademark (including, without limitation, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademark), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor or Mirejovsky had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the USPTO and in any applicable jurisdictions outside the United States to record the transfer of the registration and/or application for registration set forth on Exhibit 1 to Assignee as assignee of Assignor's entire right, title and interest therein *nunc pro tunc* July 14, 2015.

Assignor and Mirejovsky agree to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademark.

This Trademark Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

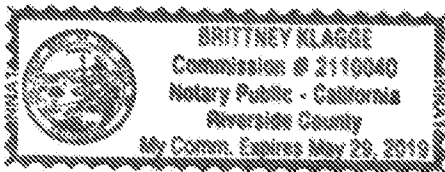

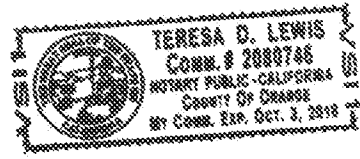

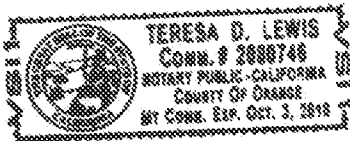
