RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of August 1, 2016, by FIFTH STREET FINANCE CORP., a Delaware corporation ("Lender") in favor of FIVE9, INC., a Delaware corporation and FIVE9 ACQUISITION LLC, a Delaware limited liability company (collectively, the "Companies") with their principal place of business located at 4000 Executive Parkway, Suite 400, San Ramon, CA 94583.

Recital
