RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of July 28, 2016 (the "Effective Date"), by Cortland Capital Market Services LLC, as collateral agent (in such capacity, the "Agent"), in favor of Maxim Crane Works, L.P., a Pennsylvania limited partnership (the "Grantor"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement (defined below) including any defined terms incorporated by reference therein from the Security Agreement as provided in the Trademark Security Agreement.

W I T N E S S E T H

WHEREAS, pursuant to the terms and conditions of that certain Grant of Second Lien Security Interest in Trademark Rights between the Grantor and the Agent dated as of May 11, 2016 (the "Trademark Security Agreement"), the Grantor pledged and granted to the Agent a lien on and security interest in all of its right, title and interest in and to certain Trademarks;

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on May 12, 2016 at Reel 5791 and Frame 0916;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the following Collateral:

All trademarks and related goodwill, including those listed on Schedule I (the "Trademark Collateral").


If and to the extent the Agent has acquired any right, title or interest in or to any of the Trademark Collateral, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Grantor.

The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at the Grantor's cost and expense, to more fully and effectively effectuate the purposes of this Release.
