Pursuant to the provisions of Section 242 of the Delaware General Corporation Law, the undersigned corporation adopts the following Certificate of Amendment to its Certificate of Incorporation (the "Certificate of Incorporation"):

1. The name of this corporation is Jeppesen Marine, Inc. (the "Company").
2. The Certificate of Incorporation of the Company was originally filed with the Secretary of State of Delaware on January 27, 2000.
3. The Amendment to Certificate of Incorporation set forth below was adopted by the Company's Board of Directors and Stockholders pursuant to a unanimous written consent dated June 9, 2016.
4. Article One of the Certificate of Incorporation is hereby deleted in its entirety and replaced by the following:

**ARTICLE I  
NAME**

The name of the corporation is C-MAP USA, INC. (the "Corporation").

5. Except as hereby amended, the Certificate of Incorporation of the Company shall remain the same.
6. This Certificate of Amendment to Certificate of Incorporation of the Company shall be effective upon filing with the Secretary of State of the State of Delaware.
