

Any use of the mark by ASSIGNOR, under the terms of this section or otherwise, shall inure to the benefit of ASSIGNEE.

This agreement shall be binding upon and shall inure to the benefit of the heirs, legal representatives, successors, and assigns of the parties hereto.



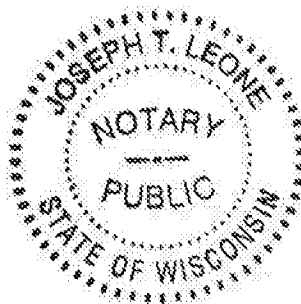
