## RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made as of August 31, 2016, by Cadence Bank, N.A., a national banking association ("Lender") with its principal place of business located at 2800 Post Oak Boulevard, Suite 3800, Houston, Texas 77056, in favor of Megel, LLC, a Texas limited liability company ("Company") with its principal place of business located at 4809 Westway Park Boulevard, Houston, Texas 77041.

### Recitals

WHEREAS, reference is made to that certain Loan Agreement, dated as of May 15, 2012, by and among Equivalent Data, LLC, a Texas limited liability company ("Borrower"), and Lender;

WHEREAS, pursuant to that certain Intellectual Property Agreement, dated as of May 15, 2012, between the Company and Lender (the "Intellectual Property Agreement"; the Intellectual Property Agreement as amended by the First Amendment (as defined below), the "Security Agreement"), Company granted to Lender a security interest in all Patent Applications, Patents, Trademark Applications, Trademarks, Copyrights, Trade Secrets, Inventions, Know-how, and other proprietary property or technology currently used in Company's business, including without limitation its trademarks described on Exhibit A attached hereto (collectively, the "Intellectual Property Collateral");

WHEREAS, the Intellectual Property Agreement was duly recorded on May 23, 2012 in the U.S. Patent and Trademark Office, Assignment Division ("USPTO") at Reel No. 4804, Frame No. 0615;

WHEREAS, the First Amendment to Intellectual Property Agreement dated as of March 18, 2014 (the "First Amendment") was duly recorded with the USPTO on April 14, 2014 at Reel No. 5259, Frame No. 0668;

WHEREAS, the obligations of Borrower to Lender under the Loan Agreement have been fully performed, and accordingly, Lender now desires to release its security interests granted pursuant to the Security Agreement in the Intellectual Property Collateral.

### Agreement

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Lender has released and discharged, and hereby releases and discharges, all of its rights, title and interest in and to the Intellectual Property Collateral, and Lender hereby releases and discharges its security interests in and any liens on the Intellectual Property Collateral.

The Lender hereby authorizes and requests the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Security Agreement and Intellectual Property.
