RELEASE OF SECURITY INTEREST

WHEREAS, GenArts, Inc., a Delaware corporation (the "Grantor") with principal offices at 955 Massachusetts Avenue, Cambridge, MA 02139, owns the trademarks and patents listed on the attached Schedule A, which trademarks and patents are registered in the United States Patent and Trademark Office (the "IP");

WHEREAS, the Grantor entered into that certain Credit Agreement dated as of October 20, 2011 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Credit Agreement"), in favor of Fifth Third Bank, an Ohio banking corporation (the "Lender");

WHEREAS, pursuant to the Credit Agreement, the Grantor granted to the Lender a continuing security interest in all right, title and interest of the Grantor in, to and under the IP, together with, among other things, the goodwill of the business symbolized by the IP and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof;

WHEREAS, the grants of security interest were recorded on behalf of the Lender in the United States Patent and Trademark Office (1) on November 4, 2011 at Reel/Frame 4655/0773 and on June 5, 2014 at Reel/Frame 5297/0262 to evidence the security interest in certain trademarks, including those set forth on Schedule A; and (2) on November 4, 2011 at Reel/Frame 027181/0462 and on June 5, 2014 at Reel/Frame 033098/00001 to evidence the security interest in certain patents, including that set forth on Schedule A;

WHEREAS, the Grantor has either satisfied or fulfilled all of its obligations to release the Lender's security interest in the IP under the Credit Agreement, and the parties seek to make a record of the Lender's release and reassignment to the Grantor of any and all of its security interests in the IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases, discharges, and relinquishes its security interests in the IP. The Lender specifically acknowledges that its security interests in the IP are no longer in force.

This Release of Security Interest shall be governed by, and construed in accordance with, the law of the State of Illinois.

IN WITNESS WHEREOF, the Lender has caused this Release of Security Interest to be duly executed by its officer thereunto duly authorized as of September 9, 2016.
