CERTIFICATE OF AMENDMENT

HEADWAY CORPORATE RESOURCES, INC., a Delaware corporation, does hereby amend its Restated Certificate of Incorporation, as amended, as follows:

1. Article I of the Restated Certificate of Incorporation, as amended, is hereby amended to read in its entirety as follows:

The name of the Corporation is Headway Workforce Solutions, Inc.

2. Section 1 of Article IV of the Restated Certificate of Incorporation, as amended, is hereby amended to read in its entirety as follows:

ARTICLE IV
CAPITAL STOCK

1. Authorized Shares. The Corporation shall be authorized to issue 120,000,000 shares of capital stock, 100,000,000 shares of which shall be Common Stock, \$0.0001 par value (the "Common Stock") and 6,000,000 shares of which shall be Series A Redeemable Non-Convertible Preferred Stock, \$0.0001 par value (the "Series A Preferred Stock") and 14,000,000 shares of which shall be preferred stock, \$0.0001 par value (the "Preferred Stock"). The Board of Directors shall have the right and power, by resolution adopted from time to time, to divide the Preferred Stock into one or more series or classes and to specify the powers, designations, preferences, and relative, participating, optional, or other rights, if any, or the qualifications, limitations or restrictions, if any, within each such series and class.

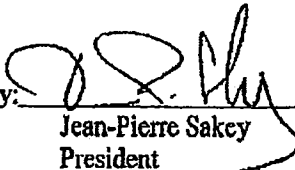
