## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (“Release”) is made and entered into as of September 21, 2016 (“Effective Date”) by and between, Cortland Capital Market Services LLC as Successor Administrative Agent, a Delaware Limited Liability Company having an office at 225 W. Washington Street, Suite 2100 Chicago, IL 60606 (“Agent”), and MAIL AMERICA COMMUNICATIONS, INC., a Delaware corporation having an office at 1174 Elkton Farm Road, Forest, VA 24551 (“Grantor”).

**WHEREAS**, Bank of America, N.A., as Administrative Agent, a Delaware limited liability having an office at 135 South LaSalle Street, Chicago, Illinois 60603 (“BOA”) was the holder of a continuing security interest in and to all of Grantor’s right, title and interest in, to and under the trademarks, service marks and related applications and registrations set forth in Schedule 1 attached hereto connected with the use of or related to any and the foregoing (including without limitation, all goodwill of the Grantor and its business, products and services appurtenant to, associated with or symbolized by any of the foregoing and the use thereof), together with all registrations of the foregoing and the applications therefor (collectively, the “Trademark Collateral”) pursuant to that certain Security and Pledge Agreement dated June 14, 2013 for which a Notice of Grant of Security Interest is recorded with the United States Patent and Trademark Office at Reel 5054, Frame 0753 (collectively, the “Security Agreement”);

**WHEREAS**, pursuant to that certain Resignation, Consent and Appointment Agreement dated January 30, 2015, BOA resigned as Administrative Agent under the Security Agreement and Agent was appointed as successor Administrative Agent and BOA assigned and delegated to Agent, all of the rights, powers (including powers of attorney), benefits, privileges, and duties and interest in, to and under the Security Agreement, including, without limitation, all liens and security interests in respect of any and all Trademark Collateral; and

**WHEREAS**, Grantor desires to record this instrument to evidence termination of the security interest.

**NOW, THEREFORE**, the Grantor and Agent in its capacity as Successor Administrative Agent agree as follows:

1. The Agent hereby expressly releases and discharges, the security interest in, to and under the Trademark Collateral pursuant to the Security Agreement.
2. The Agent hereby authorizes and requests the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Security Agreement and the Trademark Collateral.
3. This Release may be executed in multiple counterparts, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.
