INTELLECTUAL PROPERTY AGREEMENT

THIS INTELLECTUAL PROPERTY AGREEMENT (the "Agreement"), effective as of April 30, 2016, by and between The Institute of Electrical and Electronics Engineers, Incorporated, a New York not-for-profit corporation having a principal place of business at 3 Park Avenue, 17th Floor, New York, New York 10016-5997 ("IEEE"), and IEEE GlobalSpec, Inc., ("IEEE GlobalSpec"), a subsidiary of IEEE, Inc., with its office at 30 Tech Valley Drive, No. 102, East Greenbush, New York 12061.

WITNESSETH:

WHEREAS, IEEE is the owner of all right, title, and interest in and to the intellectual property identified in Schedules A-B, as may be amended from time to time by mutual agreement by the parties (the "IEEE Material");

WHEREAS, IEEE GlobalSpec is the owner of all right, title, and interest in and to the intellectual property identified in Schedules C-F, as may be amended from time to time by mutual agreement by the parties (the "IEEE GlobalSpec Material") (with the IEEE Material, collectively the "Material");

NOW, THEREFORE, in consideration of the mutual promises and intending to be legally bound hereby, the parties agree upon the following terms and conditions:

1. INTELLECTUAL PROPERTY

- A. To the best of IEEE's knowledge, IEEE is the owner of all rights, title, and interest in and to the IEEE Material or has the right to grant a license to IEEE GlobalSpec to use the IEEE Material.
- B. To the best of IEEE GlobalSpec's knowledge, IEEE GlobalSpec is the owner of all rights, title, and interest in and to the IEEE GlobalSpec Material or has the transferrable right to use the IEEE GlobalSpec Material.
- C. IEEE and IEEE GlobalSpec recognize that the owning party may not have registered all elements of the Material in all jurisdictions and that, to the extent registrations exist, the registrations may be limited in certain respects as chosen by the owning party.
- D. IEEE grants IEEE GlobalSpec a nonexclusive, royalty free, worldwide license to use the IEEE Material in connection with the advancement of IEEE GlobalSpec's interests. Such usage may include, but is not limited to, the offering, sale, and promotion of goods and services, as well as advertising, promotional material, and signage relating to IEEE GlobalSpec.

- E. In consideration of the rights granted herein, IEEE GlobalSpec assigns to IEEE all right, title, and interest in and to the IEEE GlobalSpec Material. Notwithstanding the foregoing, IEEE GlobalSpec shall retain a nonexclusive, royalty free, worldwide license to use the IEEE GlobalSpec Material in connection with the advancement of IEEE GlobalSpec's interests. Such usage may include, but is not limited to, the offering, sale, and promotion of goods and services, as well as advertising, promotional material, and signage relating to IEEE GlobalSpec.
- F. The goodwill associated with and created by the use of the Material by IEEE GlobalSpec shall inure exclusively to the benefit of IEEE.
- G. IEEE GlobalSpec will in no way represent that it has any right, title, or interest in the Material other than as expressly granted under the terms of this Agreement.
- H. IEEE GlobalSpec shall use the Material in the style, design, manner, form and with such legal notices and registration symbols as may be designated by IEEE.
- I. At IEEE's request, IEEE GlobalSpec agrees to execute all documents necessary for IEEE to properly maintain and/or register the Material in IEEE's name in in any jurisdiction. IEEE GlobalSpec will not apply to register the Material, or any part thereof, anywhere in the world, during the term of the Agreement or at any time thereafter.
- J. IEEE GlobalSpec shall have no right to sublicense or assign the license granted herein to any non-IEEE related party without the prior written consent of IEEE.

2. TERM AND TERMINATION

This Agreement shall continue until such time as it is terminated by IEEE, with or without cause, upon ninety (90) days prior written notice to IEEE GlobalSpec. In addition, this Agreement may be terminated by IEEE for any material breach by IEEE GlobalSpec of the terms and conditions of the Agreement, if the breach remains uncured for a thirty (30) day period after receipt of notice of such breach from IEEE. In the event of termination of this Agreement for any reason, IEEE GlobalSpec shall take immediate steps to cease all use of the Material, and all rights granted herein shall revert to IEEE.

3. QUALITY ASSURANCE

- A. All use of the Material under this Agreement shall be of high quality, satisfactory to IEEE in its sole discretion, and in compliance with all applicable laws, rules, and regulations of any governmental or administrative body. IEEE GlobalSpec shall further use its best efforts to uphold and maintain the value, reputation, and goodwill of the Material.

- B. In the event that IEEE determines that any good, service, or collateral material is not of the quality set forth in subparagraph A above, it shall notify IEEE GlobalSpec in writing of any deficiency in quality and IEEE GlobalSpec shall promptly make any changes or modifications requested by IEEE.
- C. Should IEEE GlobalSpec become aware of any infringement of the Material, IEEE GlobalSpec shall provide notice to IEEE of such infringement.

4. INTERPRETATION


- A. This Agreement shall be governed by and interpreted in accordance with the laws of the State of New York.
- B. This Agreement constitutes the entire agreement and understanding between the parties. Any modification or addition to the Agreement shall be by written instrument signed by the parties hereto and dated subsequent to the last date of execution below.
