INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT

THIS INTELLECTUAL PROPERTY RELEASE AND REASSIGNMENT (this “Release”) is made as of October 5, 2016, by Antares Capital LP (as successor in interest to General Electric Capital Corporation) (“Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreements (as defined below).

W I T N E S S E T H:

WHEREAS, Henry Company LLC, a California limited liability company (“Henry”) and Henry WDG, LLC, a Delaware limited liability company (“WDG” and together with Henry, the “Grantors” and each, a “Grantor”) granted a security interest in certain intellectual property of the Grantors to Agent, pursuant to that certain (i) First Lien Patent Security Agreement, dated as of June 27, 2012, by Henry in favor of Agent and recorded with the United States Patent and Trademark Office on June 27, 2012, at Reel 028456, Frame 0618, (ii) First Lien Trademark Security Agreement, dated as of June 27, 2012, by Henry in favor of Agent and recorded with the United States Patent and Trademark Office on June 27, 2012, at Reel 004809, Frame 0171, (iii) First Lien Copyright Security Agreement, dated as of June 27, 2012, by Henry in favor of Agent and recorded with the United States Copyright Office on July 13, 2012, at Volume 3618, Document 276, (iv) First Lien Patent Security Agreement, dated as of October 2, 2014, by Henry in favor of Agent and recorded with the United States Patent and Trademark Office on October 2, 2014, at Reel 033886, Frame 0659, (v) First Lien Trademark Security Agreement, dated as of October 2, 2014, by Henry in favor of Agent and recorded with the United States Patent and Trademark Office on October 2, 2014, at Reel 5373, Frame 0714, (vi) First Lien Patent Security Agreement, dated as of September 10, 2014, by WDG in favor of Agent and recorded with the United States Patent and Trademark Office on October 2, 2014, at Reel 033871, Frame 0525 and (vii) First Lien Trademark Security Agreement, dated as of September 10, 2014, by WDG in favor of Agent and recorded with the United States Patent and Trademark Office on October 2, 2014, at Reel 005373, Frame 0605 (collectively, the “Security Agreements” and each, a “Security Agreement”; capitalized terms used but not otherwise defined herein having the meanings assigned to such terms in the applicable Security Agreement);

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by the parties to the Security Agreements:

1. Agent hereby releases its entire Lien on and security interest in all of each Grantor’s right, title and interest in, to and under the Patent Collateral (including, without limitation, the Patents referred to on Schedule 1 hereto), the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule 2 hereto), and the Copyright Collateral (including, without limitation, the Copyrights referred to on Schedule 3 hereto) and authorizes the recordation of this Release with the United States Patent and Trademark Office and United States Copyright Office.

2. Agent hereby reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in, to and under the Patent Collateral, Trademark Collateral and Copyright Collateral and Agent hereby releases, terminates and cancels any mortgage, pledge and hypothecate made by the Grantors to Agent pursuant to the Security Agreements.


