RELEASE OF SECURITY INTEREST IN TRADEMARKS  
UNDER THE FIRST LIEN TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 13, 2016 by **CRYSTAL FINANCIAL LLC**, a Delaware limited liability company, in its role as Agent ("Grantee") in favor of **TRULITE GLASS & ALUMINUM SOLUTIONS, LLC**, a Delaware limited liability company, with its principal office at 403 West Park Court Suite 201 Peachtree City, GA 30269 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain First Lien Trademark Security Agreement by and between Grantor and Grantee dated May 18, 2012 (the "Trademark Security Agreement"), Grantee was granted a continuing security interest in and to all of Grantor's right, title and interest in and to the United States trademark registrations set forth on Schedule A attached hereto (the "Trademarks"), together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Term Loan Agreement by and between Grantor, Grantee, and certain other parties dated May 18, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on May 23, 2012, at Reel 4786, Frame 0089;

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee; and

WHEREAS, Grantor has requested and Grantee has agreed to provide a document suitable for recording in the PTO evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademarks (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Grantee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release, reassign, transfer and reconvey its security interest in the Released Collateral to Grantor, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Grantee in the Released Collateral.
