RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of October 14, 2016 ("Effective Date") by Fifth Third Bank, an Ohio banking corporation, ("Grantee"), in favor of Riverchase MSO, LLC, a Delaware limited liability company, and Naples Center for Dermatology & Cosmetic Surgery, P.A., d/b/a Riverchase Dermatology and Cosmetic Surgery, a Florida corporation (collectively "Grantors"),.

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantors and Grantee dated December 28, 2012 (the "IP Security Agreement"), Grantors granted to Grantee a continuing security interest in and to all of Grantors' right, title and interest in and to the Intellectual Property, including, without limitation, the Trademarks (as defined in the IP Security Agreement) set forth on Schedule A attached hereto;

WHEREAS, Grantors and Grantee entered into the IP Security Agreement pursuant to the terms and conditions of that certain Loan and Security Agreement by and between Grantors and Grantee dated December 28, 2012 (the "Security Agreement");

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office ("PTO") on January 4, 2013, at Reel 4935, Frame 0528; and

WHEREAS, Grantors have paid all of their outstanding Obligations to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the IP Security Agreement, and hereby terminates, cancels and releases any and all interests, right and title it has against the Intellectual Property (as defined in the IP Security Agreement).

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any interest, right or title it has against the Intellectual Property (as defined in the IP Security Agreement).

Grantee shall, at Grantors' expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
