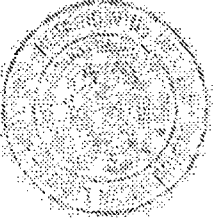

REQUEST FOR CORRECTION OF AN ERROR

Dear Sir/Madam:

On August 9, 2016, we submitted a request for recordation of an assignment regarding U.S. Registration No. 1,104,668. On August 12, 2016, we received a Notice of Non-Recordation of an Assignment Document from the Assignment branch of the United States Patent and Trademark Office ("PTO"). It was determined that the Notice of Non-Recordation was issued due to the name of the conveying party indicated on the cover sheet, namely, Discos Musart, S.A. de V.C. which is currently reflected in the PTO database did not exactly match the conveying party identified in the assignment to be recorded. The sole difference between the conveying parties name in the abbreviation of the entity status, namely, V.C. versus C.V.

An investigation was conducted that revealed the Registrant's name reflected in the PTO database incorporating the term "V.C." is incorrect and stemmed from an error in the assignment recorded May 7, 1984 at Reel/Frame 0466/0197 assigning the above-noted registration from Discos Musart S.A. to Discos Musart S.A. de V.C. As the PTO assignment database did not reveal any "supporting documents" for the assignment recorded at Reel/Frame 0466/0197, we submitted a corrective assignment to correct the Assignee's name previously recorded at Reel/Frame 0466/0197 based on the fact that the designation V.C. when used as part of a Mexican corporation does not exist and has never existed. It was clear that the individual who attended to the recordation of the assignment in 1984 transposed the proper designation for a Mexican corporation, namely, C.V. However, our corrective assignment was rejected because we did not submit the previously recorded cover sheet which contains the error and the supporting document, namely, the assignment recorded at Reel/Frame 0466/0197. attached Notices of Non-Recordation from the PTO dated August 12, 2016 and September 15, 2016.

Upon receiving the notice of Non-Recordation of the corrective assignment on September 15, 2016, we contacted the Assignment division of the PTO telephonically and was advised that while the assignment documents associated with Reel/Frame 0466/0197 were not available on the PTO's website the document may be requested from the PTO. At that time, we submitted a written request to the PTO to obtain all of the documents associated with the assignment at Reel/Frame 0466/0197 and paid the associated fees. In response to our request, we received the attached Assignment of Trademark Registration recorded at Reel/Frame 0466/0197 clearly identifying the Assignee as Discos Musart S. A. de C.V. supporting the fact that the terms were transposed at the time of recordation in 1984. However, the PTO did not provide any other information other than the attached Assignment of Trademark Registration. We specifically requested all of the documents associated with this assignment including the previously recorded cover sheet but the PTO did not provide it nor any explanation as to why it was not provided. As such, we are unable to provide the PTO with the previously recorded cover sheet but submit that the attached Assignment of Trademark Registration recorded at Reel/Frame 0466/0197 clearly identifies the Assignee as Discos Musart S.A. de C.V. not with the terms transposed, namely, V.C.


Due to the above-noted discussion, we once again request the PTO accept the subject corrective assignment to correct the typographical error in the Assignee's name emanating from the recordation of the assignment recorded at Reel/Frame 0466/0197. The attached assignment

of trademark registration submitted to the PTO in 1984 and recorded at Reel/Frame 0466/0197 clearly identifies the Assignee as Discos Musart S.A. de C.V. Once the PTO corrects the Assignee's name in the prior assignment, the new Assignee Concord Bicycle Assets, LLC will be able to record the assignment from Discos Musart S.A. de C.V. dated April 7, 2016.
