RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this 26th day of October, 2016, is made by **ALOSTAR BANK OF COMMERCE**, a state banking institution organized under the laws of the State of Alabama, with an address at 3630 Peachtree Road, NE, Suite 1050, Atlanta, Georgia 30326, as lender (the "Lender").

WITNESSETH

WHEREAS, the Grantors executed that certain Loan and Security Agreement, dated as of August 23, 2012 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), and granted to the Lender a security interest in and to all Grantor's right, title and interest in all registered trademarks, registered trademark licenses and trademark applications, including as set forth on Schedule 1 attached hereto (collectively, the "Trademark Collateral");

WHEREAS, in furtherance of the Security Agreement, the Lender executed a Trademark Security Agreement, dated August 23, 2012 (the "Trademark Security Agreement"), which was duly recorded on August 23, 2012, at Reel/Frame 4848/0355 in the United States Patent and Trademark Office;

WHEREAS, the Lender wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby grants, assigns and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademark Collateral, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademark Collateral.
