RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, BENTLEY LABORATORIES LLC, a Delaware limited liability company (the "Grantor") granted a continuing security interest in and lien upon certain trademarks, trademark applications and related rights to RIVERSIDE STRATEGIC CAPITAL FUND I, L.P. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Administrative Agent pursuant to the IP Security Agreement in the Released Trademark, without recourse or representation or warranty, express or implied, of any kind; provided, however, that nothing contained herein shall release or be deemed to release any security interest in or lien upon any proceeds from the sale of the Released Trademark paid or payable to or for the benefit of Grantor.
