# TRADEMARK ASSIGNMENT

(Nunc Pro Tunc)

This Agreement is entered into freely by and between Olav E. Sandnes, an individual having a residential address at 120 Lenape Trail, Mt. Bethel, Pennsylvania 18343 (hereinafter referred to as "Assignor") and Marine Ingredients, LLC, a limited liability company organized under the laws of Delaware, having a principal business office at 794 Sunrise Boulevard, Mt. Bethel, Pennsylvania 18343 (hereinafter referred to as "Assignee").

WHEREAS, the Assignor desires to convey, transfer, assign and deliver to the Assignee all of its rights, title and interest in and to the Trademark along with the goodwill associated therewith; and

WHEREAS, Assignce has previously been assigned the entire right, title, and interest in and to the Trademark and thereof is now desirous of confirming such assignment and of further securing its ownership of the mark;

NOW THEREFORE, Assignor hereby confirms that on or about January 1, 2015, in consideration of ten dollars (\$10.00) and other good and valuable consideration paid to the Assignor by the Assignee, the receipt and sufficiency of which are hereby acknowledged, THE ASSIGNOR ASSIGNED TO THE ASSIGNEE the entire right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by and associated with the mark.

### 1. Assignment.

- 1.1 The Assignor is assigning its interest in the Trademark and associated goodwill, all related income and royalties and any money due or that becomes due relating to an infringement or misappropriation of the Trademark as well as the right to sue for all future and past infringement and misappropriations.
- 1.2 Subject to the foregoing paragraph, the Assignor hereby conveys, transfers, assigns and delivers to the Assignee all of its rights, title and interest in and to the Trademark, together with (1) the goodwill; (2) all income, royalties and damages that become due or payable to the Assignor with respect to the Trademark, including damages and payments for past, present and future infringements or misappropriations of the Trademark.
- 1.3 No share, interest, assignment or other right to the Trademark has been transferred, assigned or granted to any other party.
- 1.4 The Assignor further conveys, transfers, assigns, delivers and contributes to the Assignce all rights in the Trade Dress, labels and designs associated with the Trademark.
- 1.5 The Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing or vesting in the Assignee full right, title and interest in the Trademark.

  - 2.3 The Trademark is free of any liens, security interests, encumbrances or licenses:
- 2.4 There are no claims, pending or threatened, with respect to Assignor's rights in the Trademark;
- 2.5 This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and
- 2.6 Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

#### 3. General Provisions.

No waiver by any part of any default in performance by the other party under this Agreement or of any breach or series of breaches by the other party or any of the terms or conditions of this Assignment shall constitute a waiver of any subsequent default in performance under this Agreement or any subsequent breach of any terms or conditions of that Assignment. Performance of any obligation required of a party under this Agreement may be waived only by a written waiver signed by a duly authorized officer of the other party, that waiver shall be effective only with respect to the specific obligation described in that waiver.
- 3.3 <u>Severability</u>. If any provision of this Agreement is found invalid or unenforceable under judicial decree or decision, the remainder shall remain valid and enforceable according to its terms. Without limiting the previous, it is expressly understood and agreed that each and every provision of this Assignment that provides for a limitation of liability, disclaimer of warranties or exclusion of damages is intended by the parties to be severable and independent of any other provision and to be enforced as such. Further, it is expressly understood and agreed that if any remedy under this Assignment is determined to have failed of its essential purpose, all other limitations of liability and exclusion of damages set forth in this section shall remain in full force and effect.
