TRADEMARK ASSIGNMENT

For TEN DOLLARS (USD) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns, transfers, and conveys to the Assignee, and the Assignee hereby accepts from the Assignor, all right, title, and interest of the Assignor in and to the Mark, together with the goodwill of the business symbolized by the Mark, with the right to recover for damages and profits and all other remedies for past infringements thereof.

This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.

The Parties have executed this Agreement by their respective duly-authorized representatives.
