**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of September 29, 2016 (this "Release"), is made by ANTARES CAPITAL LP, as successor in interest to GE Business Financial Services Inc., as administrative agent (the "Administrative Agent"), in favor of PACIFIC CRANE MAINTENANCE COMPANY, L.P. ("Grantor"), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement or Trademark Security Agreement.

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement, dated as of May 31, 2010 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 22, 2010, at Reel/Frame No. 4247/0079, Grantor granted to the Administrative Agent a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademarks set forth on Schedule A attached hereto (the "Released Registered Trademarks"); and

WHEREAS, Grantor has requested that the Administrative Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks; and

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantor.


NOW, THEREFORE, the Administrative Agent, without recourse, representation or warranty of any kind or nature, and at Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks, and any and right, title and interest of the Administrative Agent in such Trademark Collateral and such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantor.

The Administrative Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
