**TERMINATION AND RELEASE
OF TRADEMARK SECURITY AGREEMENT**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), by **M&T BANK**, a corporation of New York (the "Lender") in favor of **THE RADIANT GROUP, INC.**, a corporation of Colorado (the "Borrower").

WHEREAS, pursuant to the terms of that certain Trademark Security Agreement (the "Agreement"), dated as of August 14, 2014, by and between the Borrower and the Lender, the Borrower granted to Lender, a security interest in and to all of the right, title and interest of the Borrower in and to the trademarks listed on Schedule A attached hereto, together with the goodwill of the business symbolized by the trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the obligations;

WHEREAS, the Lender wishes to terminate and release its security interest in and to all of the right, title and interest of the Borrowers in and to the Collateral, including the Intellectual Property identified on Schedule A attached hereto; and

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on October 7, 2014 at Reel/Frame: 5376/0640; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (i) terminates the Agreement; and (ii) terminates, releases and discharges fully its security interest in and to all of the right, title and interest of the Borrowers in and to the Collateral, including the Intellectual Property identified on Schedule A attached hereto, and reassigns and transfers to the Borrowers all right, title and interest that the Lender may have in the Collateral, and terminates the Agreement. The Lender hereby authorizes the Borrowers, or the Borrowers' authorized representative, to record this Release with the United States Patent and Trademark Office and the U.S. Copyright Office.
