DEED OF ASSIGNMENT OF INTELLECTUAL
PROPERTY RIGHTS

THIS Agreement is dated 26/3/2015

PARTIES

- (1) Lister Petter Group Limited, a company incorporated and registered in England and Wales with company number 08754910 whose registered address is Castle House, Castle Hill Avenue, Folkestone, Kent CT20 2TQ ("Assignor")
- (2) Modell Enterprises Limited, a company incorporated and registered in England and Wales with company number 09750614 whose registered address is Ground Floor Office, E5 Hagley Court North The Waterfront, Level Street, Brierly Hill, United Kingdom DY5 1XF ("Assignee")

BACKGROUND

- A. The Assignor owns the Intellectual Property Rights relating to the Assets
- B. The Assignor has agreed to assign to the Assignee all such right, title and interest as the Assignor has in the Assets.

AGREED TERMS

I. INTERPRETATION

The following definitions and rules of interpretation apply in this agreement.

Definitions:

Assets means all Intellectual Property rights as are owned by the Assignor as at the date of this Agreement

Intellectual Property Rights all know-how, patents, trademarks (short particulars of which are set out in Schedule 1), service marks, designs, utility models, business names, domain names, topographical or similar rights, copyrights (including rights in computer software), design rights, moral rights, inventions, confidential information and rights of a similar nature and other intellectual property monopoly rights arising or subsisting anywhere in the world (in each case whether registered or not, and including Applications) as more particularly described and defined in the Legal Charge

The Schedule forms part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedule.

2. Assignment

In consideration of the sum of £2.5 million (the "Consideration"), the Assignor hereby assigns to the Assignee absolutely all such rights, title and interest it has in the Assets that relate to the Products.

3. Payment of Consideration

Subject to clause 3.1 below, the assignee shall pay the Assignment Fee to the Assignor in 12 quarterly instalments, with the first instalment payment becoming due and payable on 1 November, 2015.

The payments shall be inclusive of VAT, which if payable shall be paid in addition to the Consideration.


4. Further Assurance

5. Governing Law


This Assignment shall be governed by and construed in accordance with the law of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this agreement or its subject matter or formation.
