**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks ("Trademark Release") is made as of November 18, 2016, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a United States national association (the "Collateral Agent") in favor of MAGCO INCORPORATED, a New York corporation with offices at 32 Cherry Blossom Road, Cambridge, Ontario N3H 4R7 Canada (the "Grantor").

W I T N E S S E T H:

WHEREAS, Grantor entered into a certain trademark security agreement dated May 30, 2014 (the "Trademark Security Agreement") with the Agent, notice of which was recorded on May 30, 2014 at the United States Patent and Trademark Office at Reel 5291, Frame 0361.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to its Mark Collateral, including the Mark Collateral listed in Schedule I, and all the goodwill of the business symbolized thereby.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Mark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Mark Collateral of the Grantor, and all of the goodwill of the business symbolized by the Mark Collateral, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
