**PLAN OF CONVERSION
FOR CONVERSION OF
CEDEXIS INC.,
AN OREGON CORPORATION,
INTO
CEDEXIS INC.,
A DELAWARE CORPORATION**

This **PLAN OF CONVERSION** (this "Plan") is adopted by Cedexis Inc., an Oregon corporation, effective July 13, 2011.

**ARTICLE I
THE CONVERSION; EFFECTIVE TIME**

1.1. Entity Prior to and After Conversion. Prior to conversion, the business entity is Cedexis Inc., an Oregon corporation (the "Converting Corporation"). After conversion, the business entity will be Cedexis Inc., a Delaware corporation (the "Continuing Corporation").

1.2 The Conversion. Upon the terms and subject to the conditions set forth herein, at the Effective Time (as defined in Section 1.3), the Converting Corporation will be converted into, and continue its existence as, the Continuing Corporation (the "Conversion"). The Conversion shall have the effects specified in the General Corporation Law of the State of Delaware, as amended (the "DGCL"), and in the Oregon Business Corporation Act, as amended (the "OBCA"), and the Continuing Corporation shall continue to hold, without transfer, all of the assets and property (whether real, personal or mixed), rights, privileges, franchises, immunities and powers of the Converting Corporation, and shall continue to be subject to all of the duties, liabilities, obligations and restrictions of every kind and description of the Converting Corporation.

1.3. Effective Time. After (a) the Board of Directors of the Converting Corporation has adopted this Plan and submitted it to the shareholders of the Converting Corporation for approval and (b) subsequent approval of this Plan by the shareholders of the Converting Corporation, and provided that this Plan has not been terminated or abandoned pursuant to Section 5.1, the Converting Corporation shall cause Articles of Conversion to be executed and filed with the Secretary of State of the State of Oregon (the "Oregon Articles of Conversion") and a Certificate of Conversion and a Certificate of Incorporation to be executed and filed with the Secretary of State of the State of Delaware (the "Delaware Certificates of Conversion and Incorporation"). The Conversion shall become effective on the date and at the time of filing of the Oregon Articles of Conversion with the Secretary of State of the State of Oregon or the Delaware Certificates of Conversion and Incorporation with the Secretary of State of the State of Delaware, whichever occurs later (the "Effective Time").

**ARTICLE II
CHARTER AND BYLAWS OF THE CONTINUING CORPORATION**

2.1. The Certificate of Incorporation. The Certificate of Incorporation of the Continuing Corporation, in the form attached hereto as Exhibit A, which will be filed with the Secretary of State of the State of Delaware and will be in effect at the Effective Time shall continue to be the Certificate of Incorporation of the Continuing Corporation, until amended in accordance with the provisions provided therein or applicable law.
