DECLARATION OF KEVIN HERRIG


I, Kevin Herrig, hereby declare as follows:

1. My name is Kevin Herrig. I am over eighteen (18) years of age, laboring under no physical or mental disabilities and am competent to make this affidavit. I have personal knowledge of the matters set forth herein and if called to testify, I could and would competently testify as set forth below.
2. I have been the Chief Executive Officer of Global Systems Integration, Inc., a Georgia corporation, (the "Company") since 2004.
3. The Company owns all right, title, and interest in the registrations for RAPIDRECONCILER (Reg. No. 3,046,879) and ANDREWS CONSULTING (Reg. No. 4,352,382) (the "Marks"), by virtue of their assignment to the Company by Andrews Consulting Group, Inc., a Connecticut corporation, and The Andrews Group, LLC, and Connecticut limited liability company on July 31, 2013, which assignment was recorded with the U.S. Patent and Trademark Office ("USPTO"), on August 5, 2013 at reel 5084, frame 0785.

4. Andrews Consulting Group, Inc., recorded the change of its name to Datalytics Technologies Holdings, Inc. ("Datalytics") with USPTO on April 15, 2014 at reel 5260, frame 0868.
5. Datalytics recorded an assignment with USPTO on November 6, 2015 at reel 5668, frame 0745 purporting to convey all right, title, and interest to the Marks to Datalytics Technologies Holdings, LLC. On November 20, 2015, Datalytics Technologies Holdings, Inc. recorded a corrective assignment at reel 5673, frame 0617 correcting the name of the purported assignee to Datalytics Technologies, LLC.
6. Datalytics' assignment of the Marks to Datalytics Technologies, LLC, and its subsequent recordation thereof was not proper because it did not possess any legal rights in the Marks at the time the assignment was made. This is because Datalytics had already assigned all right, title, and interest to the Company on July 31, 2013.
7. It is my belief that Datalytics' 2015 assignment to Datalytics Technologies, LLC resulted from an inadvertent and unintentional error. The Company has been unable to reach Datalytics Technologies, LLC about this matter. An investigation by Company counsel indicates that Datalytics Technologies, LLC has been dissolved since May 26, 2016.

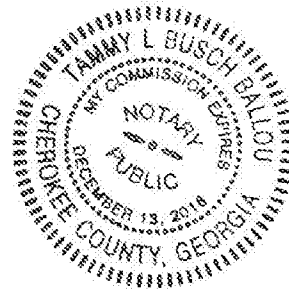
