NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN  
TRADEMARKS SUPPLEMENTAL FILING

**NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS SUPPLEMENTAL FILING**, dated as of December 6, 2016 (this "Agreement"), by TZ Insurance Solutions LLC (the "Grantor"), in favor of Cortland Capital Market Services LLC, as collateral agent for the Secured Parties (as defined in the Note Purchase Agreement referred to below) (in such capacity, the "Agent").

## WITNESSETH:

WHEREAS, pursuant to the Second Lien Credit Agreement dated as of July 21, 2016 (together with all exhibits and schedules thereto and as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among CD&R TZ Purchaser, Inc. (the "Issuer"), CD&R TZ Midco, Inc., the Lenders (as defined in the Credit Agreement) and Cortland Capital Market Services LLC, as collateral agent for the Secured Parties (as defined in the Credit Agreement) (in such capacity, the "Original Agent"), the Lenders have severally agreed to make Loans (as defined in the Credit Agreement) and other extensions of credit to the Issuer upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantor is party to that certain Second Lien Pledge and Security Agreement dated as of July 21, 2016 in favor of the Original Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Original Security Agreement") pursuant to which the Grantor executed and delivered the Notice and Confirmation of Grant of Security Interest in Trademarks by Grantor in favor of Original Agent on July 22, 2016 (the "Original Agreement");

WHEREAS, the Credit Agreement and Original Security Agreement are terminated as of the date hereof;

WHEREAS, the Grantor and Agent would like to supplement the Original Agreement, as the Issuer, CD&R TZ Midco, Inc., the Purchasers, and the Agent, in place of the Credit Agreement, have entered into the Second Lien Note Purchase Agreement dated as of December 6, 2016 (together with all exhibits and schedules thereto and as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Note Purchase Agreement"), pursuant to which the Purchasers have severally agreed to purchase the Notes of the Issuer upon the terms and subject to the conditions set forth therein; and

WHEREAS, the Grantor is a party to a Second Lien Pledge and Security Agreement dated as of December 6, 2016, in place of the Original Security Agreement, in favor of the Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") pursuant to which the Grantor agreed to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the premises and to induce the Purchasers, and the Agent to enter into the Note Purchase Agreement and to induce the Purchasers to purchase the Notes thereunder, the Grantor hereby agrees with the Agent as follows:

**Section 1. Defined Terms**

Unless otherwise defined herein, terms defined in the Note Purchase Agreement or in the Security Agreement and used herein have the meaning given to them in the Note Purchase Agreement or the Security Agreement, as the case may be.

**Section 2. Notice and Confirmation of Grant of Security Interest in Trademark Collateral**

Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations, hereby confirms the grant, made pursuant to the Security Agreement, to the Agent for the benefit of the Secured Parties, of a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of Grantor, subject to existing licenses to use the Trademarks granted by Grantor (the "Trademark Collateral"):

(a) all Trademarks owned by Grantor, including, but not limited to, those set forth on Schedule I hereto;

(b) all rights to sue at law or in equity for any past, present and/or future infringement or impairment of any of the foregoing, including the right to receive all proceeds and damages therefrom; and

(c) all Proceeds with respect to any of the foregoing, including claims, license fees, royalties and any other fees or payments.

**Section 3. Security Agreement**

This Agreement confirms the security interest granted to the Agent pursuant to the Security Agreement, and has been executed and delivered by the Grantor for the purpose of recording the grant of security interest with the United States Patent and Trademark Office. Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

**Section 4. Counterparts**

This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


**Section 5. Governing Law**

This Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the United States, in respect of trademark issues and, in all other respects, including as to validity, interpretation and effect, by the laws of the State of New York, without giving effect to its principles or rules of conflict of laws to the extent such principles or rules are not mandatorily applicable by statute and would require or permit the application of the laws of another jurisdiction.
