CONFIRMATORY ASSIGNMENT

THIS ASSIGNMENT confirms and restates the assignment made by and between **ONXEO S.A.**, a French corporation, having its principal place of business at 49 Boulevard du Général Martial Valin, Paris, France 75015, hereinafter referred to as **ASSIGNOR**, and **DARA BIOSCIENCES, INC.**, formerly a corporation of the state of Delaware, having its principal place of business at 8601 Six Forks Road, Suite 160, Raleigh, North Carolina, hereinafter referred to as **ORIGINAL ASSIGNEE**, in the commercialization agreement executed on March 9, 2015 (the "Commercialization Agreement");

WHEREAS, [REDACTED] **ORIGINAL ASSIGNEE** was acquired by and merged with **MIDATECH PHARMA US INC.**, a corporation of the state of Delaware, having its principal place of business at 8601 Six Forks Road, Suite 160, Raleigh, NC 27615, hereinafter referred to as **ASSIGNEE**;

WHEREAS, as shown by the records of the United States Patent and Trademark Office at Reel 4719/Frame 0021 and Reel 5686/Frame 0746, **ASSIGNOR** had previously acquired all right, title, and interest in and to U.S. Trademark Registration No. 3,966,483 for the mark **ORAVIG** (hereinafter referred to as "the **ORAVIG Trademark**");

WHEREAS **ASSIGNEE** is desirous of evidencing ownership of the entire right, title, and interest in and to the **ORAVIG Trademark**;

WHEREAS the parties have concluded the Commercialization Agreement in which the assignment of the **ORAVIG Trademark** was made (the "Assignment"); and

WHEREAS, the parties have agreed to confirm the Assignment hereinafter set forth;

NOW, THEREFORE, To All Whom It May Concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the above **ASSIGNOR** has sold, assigned, transferred, and conveyed unto said **ORIGINAL ASSIGNEE**, and thereby its successor said **ASSIGNEE**, its entire right, title, and interest in and to the **ORAVIG Trademark** and the associated usage and goodwill, including all rights of action against third parties for past, present and future infringement or other unauthorized use of the **ORAVIG Trademark**, the same to be held and enjoyed by said **ASSIGNEE** as fully and entirely as the same would have been held by **ASSIGNOR** had this transfer, assignment, and sale not been made.


From time to time after the date hereof, at the request of either party hereto, and at the expense of the party so requesting, each of the parties hereto shall execute and deliver to such

requesting party such documents and take such other action as such requesting party may reasonably request in order to consummate more effectively the transactions contemplated hereby.

The ASSIGNOR further covenants and agrees that, at the time of the execution and delivery of these presents, it possessed full title to the ORAVIG Trademark as earlier identified, and that it had the unencumbered right and authority to make this assignment.
