**TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of November 22, 2016, by and between IQ Health, LLC (the "Grantor"), a Florida limited liability company with offices at 950 Peninsula Corp Cir #3016, Boca Raton, Florida 33487 and Lewis J. Warshauer, M.D. and Janet G. Warshauer, joint tenants with right of survivorship (the "Lender"), having an address at 144 Viera Drive, Palm Beach Gardens, Florida 33418.

WHEREAS, Lender and Grantor entered into a Loan and Security Agreement dated as of November 24, 2014 (the "Loan Agreement") whereby the Lender loaned a certain sum of money to the Grantor to assist the Grantor in meeting certain financial obligations (the "Loan"); and

WHEREAS, as security for the Loan, Lender and Grantor entered into that certain Trademark Security Agreement, dated as of November 24, 2014 (the "Trademark Security Agreement"), and recorded with the United States Patent and Trademark Office on December 11, 2014 at Reel/Frame number 5423/0410, whereby Grantor granted to Lender a lien on and security interest in and to all of Grantor's right, title and interest in, to and under certain Trademark Collateral (as defined in the Trademark Security Agreement), including, but not limited to, the trademarks set forth on **Schedule A** attached hereto (the "Marks") and such other rights set forth in the Trademark Security Agreement; and

WHEREAS, there is a zero balance due and outstanding from the Grantor to the Lender under the Loan Agreement; and

WHEREAS, the Grantor has requested that the Lender release its lien on and security interest in, all right, title and interest of Lender in and to the Trademark Collateral, including, but not limited to, the Marks and such other rights set forth in the Trademark Security Agreement.


