## ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (the "Agreement") by and between Scar Heal, Inc. (the "Assignor"), a Florida corporation, and Atlantic Medical Products, LLC (the "Assignee") a Florida limited liability company, is effective as of December 1, 2016 (the "Effective Date").

### Background Information

The Assignor and Assignee entered into an Asset Purchase Agreement (the "Agreement") dated on or about October 11, 2016 wherein, among other things, the Assignor agreed to sell certain intellectual property, including certain trademarks as set forth on Schedule 2.1(a) to the Agreement and Exhibit A attached hereto, to Assignee. To confirm the foregoing, the Assignor wishes to assign the trademarks to Assignee and Assignee agrees to accept such assignment. Accordingly, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows.

### Operative Provisions

1. Assignment. Effective as of the Effective Date, the Assignor hereby irrevocably assigns to the Assignee all of its right, title, and interest in and to the trademarks listed on Schedule 2.1(a) to the Agreement and on the attached Exhibit A.

2. Assumption. Effective as of the Effective Date, the Assignee hereby irrevocably agrees to assume all of the Assignor's right, title, and interest in and to the trademarks listed on Schedule 2.1 (a) to the Agreement and on the attached Exhibit A.

3. Binding Obligation. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

4. Counterparts. The Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

This Agreement is effective as of the day and year first written above.


