## Assignment Agreement

THIS ASSIGNMENT AGREEMENT (the "Assignment Agreement") is made this 25<sup>th</sup> day of March, 2013 (the "Effective Date"),

Between

- (1) Delphi Connections Systems Holding France SAS (formerly known as FCI Automotive Holding SAS), a company organized under the laws of France, having its principal office at 18 Parc Ariane III, 3/5 rue Alfred Kastler, 78284 Guyancourt Cedex, France

- hereinafter referred to as "Assignor"

And

- (2) Delphi International Operations Luxembourg S.ar.l. (formerly known as Delphi Holdings Luxembourg S.ar.l.), a company organized under the laws of Luxembourg, having its principal office at Avenue de Luxembourg, 4940 Bascharage, G.D. Luxembourg

- hereinafter referred to as "Assignee"

- Assignor and Assignee hereinafter each referred to as a "Party" and together as the "Parties"

WHEREAS, FCI Automotive Holding SAS changed its name to Delphi Connections Systems Holding France SAS on October 26, 2012, as evidenced in Schedule A attached hereto;

WHEREAS, Assignor is the owner of certain rights, title, and interests to intellectual property assets; and

WHEREAS, Assignee is desirous of acquiring Assignor's entire right, title and interest in Assignor's intellectual property through an Assignment Agreement;

NOW THEREFORE, the Parties agree as follows:

### DEFINITIONS

1. "Copyrights" shall mean any and all (i) copyrights, works of authorship or copyrightable works existing anywhere (registered, published, unpublished, protected by statutory law or otherwise) and registrations, renewals, revivals, reissuances, extensions and applications for copyright registration thereof, and all rights therein provided by international treaties or conventions; (ii) moral rights (including, without limitation, rights of paternity and integrity), and waivers of such rights by others; (iii) database and data protection rights whether or not based on copyright; and (iv) rights to sue or recover and retain damages and costs and attorneys' fees for present, future and past infringement of any of the foregoing.

2. "DCS-HF Intellectual Property" shall mean any and all of Assignor's rights, title, obligations, and interests in Trademarks, Patents, Copyrights, Know-How, domain names (including but not limited to those listed in Schedule B), Co-Owned Patents, and related rights received from others to the extent assignable.
3. "Intellectual Property" shall mean Patents, Trademarks, Copyrights, Software, and Know-How.
4. "DCS-HF Intellectual Property Licenses" shall mean license agreements for DCS-HF Intellectual Property licensed to a third party.
5. "Know-How" shall mean proprietary technical and business knowledge and information, regardless of whether recorded and, if recorded, regardless of the media in which it is recorded, such knowledge and information including specifications, designs, methodologies, processes and production techniques, technologies, manufacturing and production processes, research and development information, drawings, specifications, designs, plans, proposals, technical data, formulae, algorithms, vendor and marketing and business data and customer and vendor lists and information, whether or not confidential together with the rights to sue or recover and retain damages and costs and attorneys' fees for present, past and future misappropriations or otherwise of any of the foregoing.
6. "Co-Owned Patents" shall mean Patents that Assignor has a co-ownership interest.
7. "Patents" shall mean: (i) patentable inventions, whether or not reduced to practice, and whether or not yet made the subject of a pending patent application or applications; (ii) designs, ideas and conceptions of patentable subject matter, including, without limitation, any invention disclosures and inventor certificates, whether or not reduced to practice and whether or not yet made the subject of a pending patent application or applications; (iii) national and multinational invention and design registrations or applications, patents and patent applications, including but not limited to those listed in Schedule C, provisionals, substitutions, reissues, divisionals, continuations, continuations-in-part, extensions and reexaminations and all rights, in each case provided by international treaties or conventions; and (iv) rights to sue or recover and retain damages and costs and attorneys' fees for present, future and past infringement of any of the foregoing.
8. "Software" shall mean intangible rights related to computer software and programs, including source code, object code, shareware, firmware, middleware, courseware, open source code, operating systems and specifications, system data, record and table layouts, databases, files documentation, storage media, manuals and other materials related thereto, in each case including all customizations, interfaces, enhancements and other modifications related to the foregoing.
9. "Trademarks" shall mean trademarks, service marks, trademark and service mark applications and registrations, including but not limited to those listed in Schedule D, trade names, trade dress, fictitious names, assumed names, logos and slogans, together with all goodwill related to the foregoing and all rights to sue or recover and retain damages and costs and attorneys' fees for present, future and past infringement of any of the foregoing.

## TERMS


10. To the extent assignable and subject to any required consents and clearance of any other restrictions or third party rights, as of the Effective Date, Assignor does hereby sell, assign, convey and transfer to Assignee its entire right, title, and interest, free from all liens, charges and encumbrances, in and to the DCS-HF Intellectual Property to the extent legally permissible, together with all of the goodwill associated therewith, and Assignee hereby accepts such assignment.
11. To the extent assignable and subject to any required consents and clearance of any other restrictions or third party rights, Assignor hereby sells, assigns, conveys and transfers all of the DCS-HF Intellectual Property Licenses to Assignee including but not limited to all rights, obligations, and interests (including the right to collect royalties as of the Effective Date), and Assignee hereby accepts such assignment.
12. In consideration of the foregoing, Assignee shall pay the amount of [REDACTED] to Assignor, in addition to such other good and valuable consideration, the receipt of which is hereby acknowledged by Assignor.
13. Assignee shall record the transfer of the DCS-HF Intellectual Property in all appropriate government offices and shall pay all associated costs, expenses, and fees incurred for the transfer and re-registration of the DCS-HF Intellectual Property.
14. The Parties undertake to assist each other in effecting any transfer and assignment and registration of Assignee as owner of the DCS-HF Intellectual Property without delay, and shall, at the request of the other party, promptly perform all acts necessary for such completion and submit in due form any declaration, statements and signatures required therefore.
15. For the convenience of the Parties, any number of counterparts of this Assignment Agreement may be executed by the Parties to this Assignment Agreement. Each such counterpart shall be, and shall be deemed to be, an original instrument, but all such counterparts taken together shall constitute one and the same Assignment Agreement. Delivery of this Assignment Agreement or an executed counterpart by facsimile or e-mail shall be deemed a good and valid execution and delivery of this Assignment Agreement.
16. This Assignment Agreement will be construed and enforced in accordance with the laws of Luxembourg, without giving effect to rules governing the conflict of laws.
17. Any disagreement or dispute between the parties arising under this Agreement or in connection with the transactions hereunder, which cannot be promptly resolved on an amicable basis, shall be referred to arbitration to be held in Luxembourg by a single arbitrator in accordance with the rules of the International Chamber of Commerce Rules of Arbitration in effect on the Effective Date. The arbitral award including apportionment of fees and expenses shall be final and binding upon the parties.
18. Assignor may inform its employees, customers and/or suppliers of the substance of this Assignment Agreement as deemed necessary. The Parties will consult with each other before issuing any press releases with respect to this Assignment Agreement or the transactions contemplated hereby, and will not issue any press release without mutual consent, except as may be required by Law and then only with such prior

consultation. Notwithstanding the foregoing, the Parties may make any public filing contemplated in this Assignment Agreement without the need for prior consultation; provided, however, to the extent practicable, the filing Party will provide a copy of such public filing to the other Party prior to its submission.


19. If any term or other provision of this Assignment Agreement is invalid, illegal or incapable of being enforced under any law or public policy, all other terms and provisions of this Assignment Agreement shall nevertheless remain in full force and effect. If any term or provision of this Assignment Agreement is determined to be unenforceable by reason of its extent, duration, scope or otherwise, then the parties contemplate and request that the court making such determination shall reduce such extent, duration, scope or other provision and enforce them in their reduced form for all purposes contemplated by this Assignment Agreement.
