**PARTIAL RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

PARTIAL RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (“Release”), dated as of December 7, 2016 by **WEBSTER BANK, NATIONAL ASSOCIATION**, a national association (the “Administrative Agent”), in favor of **HEALTH INFORMATION DESIGNS, LLC**, a Alabama limited liability company (the “Company”).

WHEREAS, pursuant to the terms of that certain Grant of Security Interest (Trademarks) (the “Agreement”), dated as of May 15, 2012, by the Company in favor of the Administrative Agent, the Company granted to the Administrative Agent a security interest in and to all of the right, title and interest of the Company in and to, among other things, the trademark listed on Schedule A attached hereto, which trademark is registered in the United States Patent and Trademark Office (the “Schedule A Trademark”), together with the goodwill of the business symbolized by the Schedule A Trademark, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement of the Schedule A Trademark (the “Schedule A Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement referred to in the Agreement);

WHEREAS, the Agreement was filed on May 23, 2012 with the United States Patent and Trademark Office in Reel: 4785; Frame: 0843;


WHEREAS, the Company has therefore requested that the Administrative Agent release its security interest in the Schedule A Collateral; and

WHEREAS, the Administrative Agent wishes to release its security interest in and to all of the right, title and interest of the Company solely in and to the Schedule A Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby releases and discharges fully its security interest in and to all of the right, title and interest of the Company in and to the Schedule A Collateral, and reassigns and transfers to the Company all right, title and interest that the Administrative Agent may have in the Schedule A Collateral. The Administrative Agent hereby authorizes the Company, or the Company’s authorized representative, to record this Release with the United States Patent and Trademark Office. Except for the Release referenced herein, the Agreement remains in full force and effect. The foregoing Release shall apply only to the security interest in the Schedule A Collateral and not to any of the other security interests granted pursuant to the Agreement, all of which shall otherwise remain in full force and effect.
