**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

November 17, 2016

WHEREAS, pursuant (i) that certain Trademark Security Agreement as of August 19, 2015, between Pexco LLC and Spectrum Plastics Group, Inc. (the “Grantors”) and BMO Harris Bank N.A., as administrative agent (the “Administrative Agent”) for the Lenders (the “Lenders”) and recorded in the United States Patent and Trademark Office on August 19, 2015 at Reel 5603 and Frame 0170 and (ii) that certain Security Agreement, dated as of August 19, 2015 (the “Security Agreement”), by and among the Grantors, each other grantor party thereto and the Administrative Agent, the Grantors assigned to and granted to the Administrative Agent for the Administrative Agent’s benefit and for the ratable benefit of the Lenders, a security interest in certain collateral, including the Trademark Collateral (as defined in the Security Agreement); and

WHEREAS, the Administrative Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office the release, relinquishment and discharge of its security interest in the Trademark Collateral;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Administrative Agent did and hereby does relinquish, release and discharge, on behalf of itself and the Lenders, its security interest in the following Trademark Collateral:

- (a) all United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing;
- (b) the registrations and applications listed on Schedule A attached hereto;
- (c) all extensions or renewals of any of the foregoing;
- (d) all of the goodwill of the business connected with the use of and symbolized by the foregoing;
- (e) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and
- (f) all Proceeds of the foregoing, including license fees, royalties, income, payments, claims, damages and proceeds of suit.
