The undersigned hereby certify as follows:

1. They are the President and Secretary, respectively, of TriNet HR Corporation, a California corporation (the "Corporation").
2. The Articles of Incorporation of this Corporation are hereby amended and restated to read in their entirety as set forth in Exhibit A attached hereto (the "Restated Articles").
3. The Restated Articles have been duly approved by the Board of Directors of the Corporation.
4. The Restated Articles have been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the Corporation is 1,000. The number of shares voting in favor of the amendment and restatement equaled or exceeded the vote required. The percentage vote required was more than 50%.
5. The original Articles of Incorporation of this Corporation were filed with the Secretary of State of California on March 20, 2003. The original name of this Corporation was TriNet Acquisition Corporation, which name was subsequently changed to TriNet HR Corporation by a Certificate of Amendment filed with the Secretary of State of California on January 1, 2007.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.



EXHIBIT A**RESTATED ARTICLES OF INCORPORATION**

of

TRINET HR III, INC.**ARTICLE I.**

The name of this corporation is TriNet HR III, Inc. (the "Corporation").

ARTICLE II.

Requesting a future file date of January 1, 2017.

ARTICLE III.

The purpose of this Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, trust company business or practice of a profession permitted to be incorporated under the California Corporations Code.

ARTICLE IV.

The Corporation is authorized to issue only one class of stock, to be designated Common Stock. The total number of shares of Common Stock presently authorized is one thousand (1,000), par value one tenth of one cent (\$0.001) per share.

ARTICLE V.

(a) The liability of directors of this Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

(b) The Corporation is authorized to provide indemnification (including the advance of expenses) of agents (as defined in Section 317 of the California Corporations Code) for breach of duty to the corporation and its shareholders through bylaw provisions or through agreements with the agents, or through shareholder resolutions, or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject to the limits on such excess indemnification set forth in Section 2304 of the California Corporations Code.

(c) Any repeal or modification of this Article shall only be prospective and shall not affect the rights under this Article in effect at the time of the alleged occurrence of any act or omission to act giving risk to liability or indemnification.
