**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of December 28, 2016 from NXT Capital, LLC, a Delaware limited liability company, having an address at 191 North Wacker Drive, Suite 1200, Chicago Illinois 60606, as administrative agent for the lenders (the "Administrative Agent") in favor of Rita's Water Ice Franchise Company, LLC, a Delaware limited liability company ("Grantor").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, dated as of November 30, 2011 made by the Grantor (as defined therein) in favor of the Administrative Agent, a security interest (the "Security Interest") was granted by the Grantor to the Administrative Agent, for the benefit of the lenders, in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 2, 2011 at Reel 4671 and Frame 0678; and

WHEREAS, Administrative Agent, at the request of Grantor, now agrees to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto. The term "Trademark" shall have the meaning provided by reference in the Trademark Security Agreement.


2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void.
