This Assignment also assigns all of Assignor's rights to enforce the right in the Assigned Mark throughout the world, all rights to make any claims of any past, present or future infringement, misappropriation or unauthorized use of any of the foregoing rights, and all of Assignor's rights to collect all past, present and future income, royalties, damages and payments with respect to any of the foregoing rights.

This Assignment shall be governed and construed in accordance with the laws of the United States of America and of the State of Ohio notwithstanding its conflict of law provisions. At any time and from time to time hereafter, at the other party's request, each party shall take any and all steps and shall execute, acknowledge and deliver to the other party any and all future instruments and assurances necessary or reasonably requested in order to more fully carry out the purposes hereof. This Assignment is not assignable by the Assignor without the Assignee's prior written consent. This Assignment is binding upon the Assignor, and its heirs, executors, administrators, legal representatives and permitted assigns. This Assignment and any of the Assignee's rights, title and interests under this Assignment may be assigned by Assignee or any of its successors or assigns without the Assignor's consent. This Assignment is binding upon and inure to the benefit of the Assignee and its successors and assigns.
