RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is granted and conveyed as of January 13, 2017, by and between Wells Fargo Bank, National Association ("Assignee"), in favor of Bonamar, Corp., a Florida corporation, ("Assignor").

Assignee specifically acknowledges that all such security interests are no longer effective, and that Assignee does not own any rights to or have any ownership interest in the Trademarks and the Trademark Collateral related or associated with such Trademarks. Assignor specifically acknowledges and agrees that no security interest granted pursuant to the Patent and Trademark Security Agreement, other than the security interest in the Trademarks identified on Exhibit A attached hereto and corresponding Trademark Collateral, is released, discharged or relinquished under this Release or otherwise and the Patent and Trademark Security Agreement shall remain in full force and effect for all other Trademark Collateral (as defined in the Trademark Security Agreement).
