## TRADEMARK ASSIGNMENT

NOW THEREFORE, in consideration of the foregoing, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns, transfers and conveys to the Assignee all of its right, title and interest in and to all of the Trademark Rights, whatever those rights may be, including without limitation any and all registrations, applications, and/or common law rights for the Trademark Rights throughout the world, together with all of the goodwill of Assignor's business symbolized by or associated therewith, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including, without limitation, damages and payments for past, present or future infringements. Assignor hereby authorizes and requests the US Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Trademark Rights and to issue all corresponding registrations to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.
