TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is dated as of December 23, 2016 (this "Assignment") by and between Hobsons, Inc., a Delaware corporation ("Assignee"), and RepVisits LLC, a Connecticut limited liability company ("Assignor").

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of the date hereof (the "Asset Purchase Agreement"), among Assignee, Assignor, and Erica Lee White, Assignor has agreed to assign to Assignee all of Assignor's right, title and interest in and to the trademarks and those applications and registrations (if any) listed on attached Schedule A, together with the goodwill associated therewith (the "Marks"); and

WHEREAS, Assignor wishes to assign the Marks to Assignee and Assignee wishes to accept the Marks from Assignor.

NOW, THEREFORE, in consideration of the Asset Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignor hereby assigns to Assignee all of Assignor's right, title, and interest in and to the Marks.
2. All rights and privileges, including the right to sue for and receive all damages from past infringements of the Marks, will be held and enjoyed by Assignee and its successors, assigns and other legal representatives.
3. Assignor agrees to execute and deliver at a future date any additional documents that Assignee reasonably determines are required to perfect Assignee's ownership of or title to the Marks.
4. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of any and all of the Assignor's rights in the Marks.
5. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to any of the conflict of law rules thereof.
6. This Assignment shall be effective as of the Closing.
7. This Assignment may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or other electronic delivery will be effective as delivery of a manually executed counterpart of this Assignment.
