**TERMINATION OF GRANT OF SECURITY INTEREST IN UNITED STATES  
TRADEMARKS**

This Termination of Grant of Security Interest in United States Trademarks (this "Termination"), dated as of January 25, 2017, is executed by DEUTSCHE BANK TRUST COMPANY AMERICAS ("Collateral Agent"), in favor of AFFINITY GAMING, LLC (nka AFFINITY GAMING, a Nevada corporation) with an address at 3755 Breakthrough Way, Suite 300, Las Vegas, NV 89135 (the "Grantor").

**RECITALS**

WHEREAS, the Grantor and the Collateral Agent entered into that certain Grant of Security Interest in United States Trademarks (the "Trademark Security Agreement"), dated as of April 30, 2013;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on May 9, 2013 at Reel 5023, Frame 0652;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to Collateral Agent a security interest in and to certain of Grantor's intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the "Trademarks") and all of the goodwill of the business connected with or symbolized by the Trademarks; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, Collateral Agent agrees as follows:

1. Collateral Agent is executing and delivering this Termination as evidence of the termination of the Collateral Agent's security interest in the trademarks.
2. Collateral Agent claims no right, title or interest whatsoever in or to any of the Trademarks, and, accordingly, Collateral Agent expressly terminates, releases, and discharges any and all security interests that it has in the Trademarks and reassigns to the Grantor any and all right title and interest that it may have in, to and under (i) the Trademarks listed on Exhibit A hereto and (ii) all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of the foregoing.
3. This Termination is governed by the laws of the State of New York.
