RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 31, 2017 is made by JPMorgan Chase Bank, N.A., located at 277 Park Avenue, 22nd Floor, New York, New York 10172 (the "Assignor"), in favor of Bai Brands LLC, a New Jersey limited liability company, located at 1800 East State Street, Suite 153 Hamilton, New Jersey 08609 (the "Assignee").

W I T N E S S E T H:

WHEREAS, the Assignor and the Assignee are party to a Credit Agreement, dated as of April 8, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, the Assignor and the Assignee are party to a Pledge and Security Agreement, dated as of April 8, 2015, made by and among the Assignee, the other grantors thereto, and the Assignor (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Assignor and the Assignee are party to a Trademark Security Agreement, dated as of April 8, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Assignee granted a security interest to the Assignor in the Trademarks;

WHEREAS, under the terms of the Security Agreement, the Assignee granted to the Assignor a security interest in, among other property, certain intellectual property of the Assignee, and agreed to execute and deliver that certain Trademark Security Agreement, for recording with national, federal and state government authorities, including, but not limited to, the United States Patent and Trademark Office.

WHEREAS, pursuant to the Trademark Security Agreement, Assignee pledged and granted to the Assignor a security interest in and to all of the right, title and interest of Assignee in, to and under the following, wherever located, and whether then existing or thereafter arising or acquired from time to time, including as set forth in Schedule 1 hereto (the "Trademarks"):

(i) all trademarks (including service marks), trade names, trade dress, and trade styles, (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of any such intent-to-use trademark applications under applicable federal law), and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing;

(ii) all trademark licenses to which Assignee is a party, whether as licensee or licensor;

(iii) all renewals of the foregoing;

(iv) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof;

(v) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and;

(vi) all rights corresponding to any of the foregoing throughout the world.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on April 13, 2015, at Reel/Frame 5520/0073; and

WHEREAS, the Assignor and the Assignee desire that the Assignor terminate, release, and discharge fully its security interest in, all right, title and interest in and to the Trademarks, including, without limitation, the Trademarks set forth on Schedule 1 hereto.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby agrees with the Assignee as follows:

Section 1. Defined Terms. Unless otherwise defined herein, terms defined in the Trademark Security Agreement or Security Agreement, as applicable, and used herein have the meaning given to them in the Trademark Security Agreement or the Security Agreement, as applicable.

Section 2. Release of Security Interest. The Assignor hereby terminates, releases and discharges fully its security interest in, all right, title and interest in or to the Trademarks, including, without limitation, the Trademarks on Schedule 1 hereto, and reassigns and transfers any right, title and interest that the Assignor may have in the Trademarks to the Assignee. The Assignor hereby acknowledges and agrees that the Trademark Security Agreement is terminated.

Section 3. Recordation. The Assignor hereby authorizes the Assignee or the Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Assignor in the Trademarks, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

Section 4. Further Assurances. The Assignor hereby agrees to execute and deliver to the Assignee all termination statements, releases and similar documents that the Assignee (or its respective agent or designee) shall reasonably request in order to confirm this Release and the Assignee's right, title, and interest in or to the Trademarks, at the Assignee's sole cost and expense.

Section 5. Governing Law. **THIS RELEASE AND THE RIGHTS AND**

OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICT OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.

Section 6. Counterparts: This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.


