RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “**Release**”) is made as of February 1, 2017, by Apollo Investment Corporation, in its capacity as collateral agent for the Secured Parties (the “**Agent**”) for the benefit of Garden Fresh Restaurant Corp. (the “**Grantor**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H:

WHEREAS, the Grantor and the Agent are parties to that certain Grant of a Security Interest – Trademarks, dated as of October 3, 2013 (as amended, restated, supplemented or otherwise modified through the date hereof, the “**Security Agreement**”), pursuant to which the Grantor granted to the Agent for the benefit of the Secured Parties, a security interest in the IP Collateral, which includes all Trademarks, together with all goodwill associated therewith and symbolized thereby and the application and registrations thereof, and proceeds thereof, including, without limitation, any and all causes of action arising out of or relating to any infringement thereof and any rights to recover from past, present and future violations thereof, including those set forth on Schedule A under the heading “Trademark Registrations and Applications”;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office at Reel 5124 and Frame 0320 on October 3, 2013; and

WHEREAS, the Grantor has requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby terminate the Security Agreement and terminate, release, discharge and reassigns to the Grantor the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement to the IP Collateral, together with the goodwill of the business symbolized thereby, and any right, title or interest of the Agent in such IP Collateral, if any, shall hereby terminate, cease and become void; provided, however, that any provisions contained in a Security Document that, by its respective terms, survive the termination of the respective Security Document shall not be terminated hereby.

2. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.


