This Assignment constitutes the entire agreement between the parties pertaining to its subject matter and it supersedes all prior contemporaneous agreements, representations, and understandings of the parties. No supplement, modification, or amendment of this Assignment shall be binding unless executed in writing by all parties. If any provision of this agreement is deemed to be illegal or otherwise void, invalid, or unenforceable, such provision shall be disregarded and the remainder of this agreement without such provision shall not be affected and shall remain in full force and effect.
