RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE of Intellectual Property Security Agreement ("Release of IP Security") is executed as of January 18, 2017, by **RAIFFEISEN BANK INTERNATIONAL AG**, as security agent for the Finance Parties (the "Security Agent"), for the benefit of Automic Software GmbH (formerly known as UC4 Software GmbH) (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the IP Security Agreement (as defined below).

WHEREAS, pursuant to a Trademark Security Agreement Supplement, dated as of November 29, 2012 (the "IP Security Agreement"), between the Grantor and the Security Agent, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office (the "Office") on November 30, 2012, at Reel 4910, Frame 0305, the Grantor has granted a security interest in its right, title and interest in and to the intellectual property listed in Annex I hereto (the "Intellectual Property") to the Security Agent; and

WHEREAS, in connection with the discharge of all liabilities and obligations, the Security Agent has agreed to release the security interests created under the IP Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby releases, terminates and discharges the security interests over the Intellectual Property created by the IP Security Agreement and terminates the IP Security Agreement as of the date first written above.
