Pursuant to Title 6, Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA")

FIRST: The name of the surviving corporation is GoodGuide, Inc. (the "Surviving Corporation"), a foreign corporation.

SECOND: The jurisdiction in which the Surviving Corporation was formed is New York.

THIRD: The name of the limited liability company being merged into the Surviving Corporation is Innovadex LLC, a Delaware limited liability company.

FOURTH: An Agreement and Plan of Merger dated as of September 30, 2016 (the "Agreement of Merger"), by and between Innovadex LLC, a Delaware limited liability company and GoodGuide, Inc., a New York corporation, has been approved and executed by each of the business entities which is to merge.

FIFTH: The certificate of incorporation of the Surviving Corporation shall be its Certificate of Incorporation.


SIXTH: The merger is to become effective as of the date of filing of this Certificate.
