RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made as of February 28, 2017, by CADENCE BANK, N.A., a national banking association ("Lender") with its principal place of business located at 2800 Post Oak Boulevard, Suite 3800, Houston, Texas 77056, in favor of DEPOSITION SOLUTIONS, LLC, a Texas limited liability company (the "Company") with its principal place of business located at 2001 Ross Avenue, Suite 4800, Dallas, Texas 75201. Capitalized terms used in this Release, to the extent not otherwise defined herein, shall have the meanings given to such terms in the Intellectual Property Agreement (hereinafter defined).

Recitals

WHEREAS, reference is made to that certain Loan Agreement, dated as of February 2, 2015, by and among DEPO HOLDINGS, LLC, a Texas limited liability company ("Borrower"), and Lender (as amended, the "Loan Agreement");

WHEREAS, pursuant to that certain Intellectual Property Agreement, dated as of February 2, 2015, between the Company and Lender (as amended, the "Intellectual Property Agreement"), the Company granted to Lender a security interest in, among other Collateral, its trademarks described on Exhibit A attached hereto (collectively, the "Intellectual Property Collateral");

WHEREAS, the Intellectual Property Agreement was duly recorded on February 4, 2015 in the U.S. Patent and Trademark Office, Assignment Division ("USPTO") at Reel No. 5452, Frame No. 0756;

WHEREAS, the First Amendment to Intellectual Property Agreement dated as of September 15, 2016, was duly recorded with the USPTO on October 3, 2016, at Reel No. 5889, Frame No. 0127;

WHEREAS, Lender now desires to release its security interests granted pursuant to the Intellectual Property Agreement in the Intellectual Property Collateral.

Agreement

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Lender has released and discharged, and hereby releases and discharges, all of its rights, title and interest in and to the Intellectual Property Collateral, and Lender hereby releases and discharges its security interests in and any liens on the Intellectual Property Collateral.

Lender hereby authorizes and requests the Commissioner of Patents and Trademarks to record this Release in the United States Patent and Trademark Office with regard to the Intellectual Property Collateral and Intellectual Property Agreement.
