TRADEMARK ASSIGNMENT AGREEMENT

Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Trademark in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.

This Assignment shall be construed under and governed by the laws of the United States of America and the State of Georgia, without regard to the principles of conflict of laws. This Assignment sets forth the entire agreement and understanding between the parties relating to the subject matter. This Assignment may be signed in any number of counterparts, including electronic counterparts, with the same effect as if the signature on each counterpart were on the same instrument.
