TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“**Agreement**”), dated March 14, 2017, is made by and between **CoreGuard, LLC**, a Georgia limited liability company (“**Assignor**”), and **WindTalker, LLC** a Delaware limited liability company (“**Assignee**”).

RECITALS

A. Assignor is the owner of all rights, title and interests in and to the trademark registrations listed on Exhibit A (the “**Trademarks**”); and

B. Assignee wishes to acquire from Assignor, and Assignor wishes to transfer and assign to Assignee all Assignor’s right, title, interest and goodwill in and pertaining to the Trademarks.

AGREEMENT

NOW THEREFORE, in consideration of the foregoing recitals and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Transfer of Assigned Marks**. Assignor, on behalf of itself and its predecessors and successors in interest, hereby transfers and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s existing right, title and interest in and to the Trademarks, including, without limitation, the specific registrations identified in Exhibit A and all of Assignor’s worldwide rights in and to the Trademarks including rights of registration, common law rights and the right to sue for past and future infringement of the Trademarks, together with all of the goodwill associated with the Trademarks.
2. **Further Assurances**. The parties agree to execute any documents in any jurisdiction as may be reasonably required to accomplish the transfer and assignment of all right, title, interest and goodwill that Assignor has in the Trademarks to Assignee.
3. **Recordation**. Assignor hereby requests that the United States Patent and Trademark Office record this Assignment.
4. **Successor and Assigns**. The parties acknowledge that they are acting on behalf of, and that this Agreement shall bind and benefit, the parties and their respective successors, assigns, parents, subsidiaries, affiliates and licensees throughout the world.
