NOW, THEREFORE, in consideration of the sum of Ten U.S. Dollars (\$10.00) and other good and valuable consideration, the receipt sufficiency and reasonably equivalent value of which are hereby mutually acknowledged, Assignor covenants to and hereby does irrevocably sell, assign, transfer and convey unto Assignee, its successors and assigns, nunc pro tunc effective as of July 22, 2015, all worldwide right, title and interest in and to: (a) The Mark and all goodwill of the business symbolized by The Mark; (b) any and all registrations of The Mark, whether state, federal or foreign including without limitation The Registration; (c) any and all applications to register The Mark, whether state, federal or foreign; (d) all common law rights in, to and under The Mark; (e) any and all other rights in, to and under The Mark including without limitation any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to The Mark and/or the goodwill of the business symbolized by The Mark; and (f) all claims or causes of action Assignor has or may have in connection with The Mark,
