Assignor represents and warrants that it is the owner of enforceable rights, registered and unregistered, in and to the Marks in the United States of America.

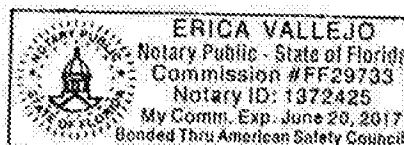

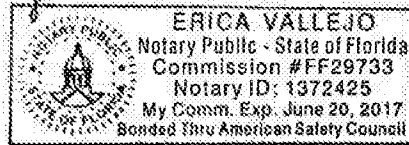
